1. The Board of Directors of **M/s. Savera Industries Limited** in its meeting held on November, 5th, 2014 has appointed me as a Scrutinizer for conducting the postal ballot and e-voting pursuant to Section 110 of the Companies Act, 2013 read with Companies (Management and Administration) Rules, 2014 for resolution set out in the Postal Ballot Notice dated 5th November, 2014.

2. I submit my report as under:



- vi. The votes cast through postal ballot forms and e-voting platform were scrutinized and the shareholding was matched/ confirmed with the Register of Members of the Company / list of beneficiaries as on the cut-off date ie.,10.11.2014.
 - vii. All postal ballot forms received upto the close of working hours on 16.12.2014, the last date and time fixed by the company for receipt of the forms, were considered for my scrutiny.
 - viii. No postal ballot forms were received after closing hours on 16.12.2014.


